SURE FILTER[®] warrants its filters to be free from defects in material and workmanship. SURE FILTER[®] automotive and heavy-duty filters are manufactured to high quality standards and guaranteed to meet all requirements of engine and equipment manufacturers.

This limited warranty extends from the date of installation of the SURE FILTER[®] product for the number of miles and driving severity published in the owner's vehicle manual as the recommended service interval for filter replacements ("Warranty Period"). SURE FILTER[®] will replace any of its filters that, under normal conditions of use, if proven to be defective in material or workmanship and is within the Warranty Period. If SURE FILTER[®] further determines, in its sole discretion that the alleged defective filter caused engine damage during the Warranty Period, SURE FILTER[®] will also repair or replace any damaged engine parts.

THIS LIMITED WARRANTY DOES NOT COVER damages caused by incorrect application, improper installation and damages or failure caused by rust or corrosion. SURE FILTER[®] is not responsible for downtime, loss of income, living expenses, or other identical consequential damages. THIS LIMITED WARRANTY IS VOID under the following circumstances:

- Use of motor oil other than the viscosity and type as recommended in the owner's vehicle manual;
- Damage or failure caused by misuse, negligence, modification, accidents or abuse;
- Damage or failure caused by unauthorized service or use of unauthorized parts.

SURE FILTER[®] reserves the right to make changes in design or improvements to its filters without creating or assuming any obligation to install or implement the same on its filters previously sold. To file a claim under this limited warranty, you must submit a warranty claim to the SURE FILTER[®] Customer Service Department within 30 (thirty) days after discovery of the damage or failure. You must also allow the SURE FILTER[®] Customer Service or its appointed representative to examine the filter, and, if required, the engine or equipment, to determine the extent of damage and whether it was caused by a defective SURE FILTER[®] product. You should retain the copy of your service records and installation record and receipt as a proof of the date of purchase. The filter must be returned to the SURE FILTER[®] Customer Service, unaltered, for examination, along with the proof of purchase, service and installation records.
